MINUTES OF THE MEETING OF THE COUNCIL

36/23 Appointment of Vice Chairman - Ratification

Resolved: That in the continued absence of the nominated Vice Chairman, Ms Bicker, the Ratification be held over until the next meeting.

37/23 Minutes of the Meeting of the Parish Council held on 07 August 2023

Resolved: That the Minutes of the Meeting of the Council held on 07 August 2023, be approved and signed by the Chairman as a correct record.

38/23 Matters Arising

- i. Security Review of Website and Re-Build (Min 26/23i) Members were continuing the general review of the upgraded website and pointed to a number of continuing omissions. The Clerk was still to meet with SWS and Councillor Dingwall undertook to review the detail and provide an update of omissions and required amendments.
- ii. Traffic Matters, Speeding, 20mph Limits, Village Entry and Exit and Speed Signs, SIDs Update including Post at Entry from Bridgwater and Off Airfield (Min 26/23ii) As previously confirmed most of the items had now been dealt with and the additional pole erected on the entry to the Village from Bridgwater, and the relocation of the SID having a positive effect. Councillor Dingwall undertook to provide updated SID information so that the application to the Police for additional SID funding could be taken forward.

Resolved: That the position be noted and the issues raised previously taken forward.

39/23 A372 Road Safety Measures Westonzoyland to Bridgwater (W/Z ACC and BACC)

As agreed at the previous meeting, the Clerk had made a formal submission on behalf of the Parish Council and it was understood that a 40mph speed limit was planned along the entire route from Westonzoyland to Bridgwater. Councillor Parfitt gave an update from the Cycling Clubs perspective, although it was now understood that Sustrans would not be able to assist because the route had been removed from the National Route Grid due to the danger of the crossing between River Lane and Ruggs Drove, making this non compliant. For Sustrans support, this would have to be improved and the route reinstated on the National Grid.

Resolved: That the Parish Council maintain their support for the speed limit and follow-up actions, and continue to press for improvements so that assistance from Sustrans can be achieved alongside the monitoring of the speed limits when introduced.

40/23 Ward Member Reports and LCN Update

Members were given an update on the Local Community Network - Levels and Moors, which had met at Westonzoyland on 20.09.23. Discussion took place on points of issue across which was the largest LCN, major issues raised, and plans for two working groups. Councillor Dingwall also gave an update on Somerset Council specific matters.

Resolved: That the reports be noted, and the LCN meeting notes circulated to all members.

41/23 Police/PCSO Report

No additional information had been received other than that circulated. The Chairman agreed to make contact with the Police about a further Police Surgery to be held in the Village.

42/23 Finance - Accounts for Payment and Receipts

Resolved: That the Accounts listed for payment (including Section 137 payments where appropriate) and paid contained in the Clerk's Report dated 27.09.23, including the payment to Mole Valley, be noted and approved, together with the bank statements and reconciliation and income received, including the VAT recovery amounting to £4,198.17 to end of financial year 2022/23.

The Clerk confirmed receipt of the Notice of Conclusion of Audit, together with the External Auditor Report and Certificate. He reported on the issues raised and the action taken by Public Notice and on the website.

44/23 Play Area and RoSPA Safety Inspection and Report, and Equipment Update (Min 32/23)

The Clerk reported further on the work in hand to deal with items requiring attention. Replacement and repair to be dealt with through Sovereign Play was still to be followed up.

- **4.** that in accordance with the agreement reached with MRFC, an account for £90 be submitted, being the proportion of cuts responsible to them.
